RESOLVED: To set up a task and finish working group to co-ordinate town council's response to this event including: beacon lighting, communicating with the Royal British Legion, the church and reaching out to other community groups.

Group Members: Councillors J Pickard and D Goode but the office to circulate details to all Councillors inviting them to join this task and finish group.

8.2 To consider the request from a local volunteer regarding arrangements for Bright Friday 2023 and setting the ball rolling for the Bright Friday sub-committee with the inclusion of key people from the Town. **To consider** giving the Clerk delegated authority to manage the Bright Friday budget 2023 in conjunction with the Bright Friday sub-committee.

NOTES FROM MEETING ON 10 OCTOBER 2023

Present: Margy Longhurst (ML), Shan Oakes (SO), Helen Westmancoat (HW) (Notetaker)

13th August 1770 was the day commissioners and local people met to discuss the implications of the Enclosure Act. We propose to make **13 August 2025 Knaresborough Day** to commemorate but also celebrate how things have moved on.

A book and also a play about the **Castle Yard Riot** have been produced or are being so this could be the basis of commemoration. Poverty caused by the Enclosure Act disenfranchised peasants and possibly led to the riot. Proposal to ask **Rowena Lloyd and Gwen Lloyd** to contribute music/play as 13th August falls in FEVA week. Also **Knaresborough Silver Band HW to action**

Coordinate with **Knaresborough Museum Association** on what they would like to contribute **ML to action**

David Rhodes' (DR) ideas can be used, Forest, Castle Gorge and Royal Knaresborough. Starting from the Castle there could be a progression through the town to Knaresborough House then Conyngham Hall and on to Knaresborough Forest Park along with any invited VIPs

SO to work with Knaresborough Forest Park for their input, a sort of reversal of the Enclosure Act as it will now be community owned. Celebrate and educate. Possibly have a community event in 2024 involving local artists, stressing the importance of local people looking after the land, people, nature and community **SO to action**

Extra volunteers as tourist guides are needed so ML will follow up on training through Tourist Blue Badge guides, potentially with funding from locality budgets or Town Council. She will also get out as many of the Knaresborough Forest leaflets as possible **ML to action**

The Knaresborough Forest leaflets should be updated with current information. SO to liaise with DR **SO** to action

13th August date can be publicised when Knaresborough Forest Park land is bought. Intended celebrations are in May and August. Open day at Jubilee allotments could also be part of it. A Knaresborough Day tradition could be started again, to Commemorate, Celebrate and Revitalise as a strap line. Schools should be involved with a marquee and use of the new stage at Knaresborough House or Conyngham Hall. HW has contacts at King James' School and will float the idea with them **HW to action**

Funding for the event needs to be in the Town Council Business plan and budget discussions. We should also follow up on the **Duchy lease** situation with Matt Walker. **ALL to action**

NOTES FROM MEETING ON 27 OCTOBER 2023

Present: Margy Longhurst (ML), Shan Oakes (SO), David Rhodes (DR), Helen Westmancoat (HW) (Notetaker)

13th August 1770 was the day commissioners and local people met to discuss the implications of the Enclosure Act. We propose to make **13 August 2025 Knaresborough Day** to commemorate but also celebrate how things have moved on.

Actions from the previous meeting: HW had contacted Gwen Lloyd about the book and potential play for the Castle Yard Riots that Rowena Lloyd was looking at writing and staging in 2024 for FEVA but had not yet heard back. HW had not yet contacted Knaresborough Silver Band but would do so.

HW had also contacted King James School with a view to them being involved in any play/performance. As the event is taking place in the school holidays it may be difficult to get pupils involved, but Clare Marting, Head teacher would consult with other staff and come back to us. **HW to monitor/action**

ML had been in contact with Knaresborough Museum Association. Notes from their meeting state "Knaresborough Town Council are looking to run a Knaresborough Day as well as a series of events in 2025 for the anniversary of the Forest of Knaresborough and the Enclosure Act. We could do an exhibition about the forest and include for example the castle yard riots; this could also involve a drama production".

ML had also contacted Christine Willoughby and obtained a copy of the pageant staged for the Millennium in June 2000 that could be used as a basis for 2030 celebrations.

ML to follow up with KMA

SO is working with Knaresborough Forest Park for their input, a sort of reversal of the Enclosure Act as it will now be community owned. Once the land purchase has gone through a celebration is planned that would include information about the Enclosure Act Commemoration. They are working towards a community event in 2024 involving local artists, stressing the importance of local people looking after the land, people, nature and community **SO to follow up/action**

ML had distributed the Knaresborough Forest leaflets to Tourist Information and Library. Schools should also be on the distribution list. DR will update the leaflets with current information. **DR to action**

ML had also followed up on the Tourist guide training and produced some information (attached) on what would be needed. It would be good training for those

needing it, and also useful on a CV. Funding for it could be included in the Knaresborough Town Council budget and business plan. ML & HW to action

ML would also contact Mark Smith who does walking tours to see if something could be arranged. **ML to action**

David Rhodes' (DR) ideas: There should be an Honour of Knaresborough based on the date in 1130 when the borough, forest and liberty were granted. The gorge is important. RHS Bridgewater is an example of biodiversity that we could use. He had put together a leaflet with key dates in Knaresborough's history. We should look to the Nidd Gorge Advisory Partnership. SO is involved in it. Also the Atkins report on the High Street, and review that. There could be a Visitor Centre at Conyngham Hall. The County would need to contact the Duchy on our behalf to have representation at the event, but he would contact the Chair of the White Rose Forest. DR would email further plans and ideas for the 2025 event, and the wider castle to the group. DR to action

DR thinks that the Duchy lease is the County's responsibility. There has been some discussion about it and Matt Walker is trying to pursue further. DR's thoughts are that we need to have a County officer to attend the Castle Area Projects subcommittee. The Courthouse Museum should be the main museum, although the Museum Association is looking at the feasibility of other locations in the town.

Group to consider the format of the day, the list of people to invite to include Chairs of the Northern Forest, Woodland Trust, the Town Crier etc. so that a more formal plan could be arranged. **ALL to action**

NYC should be involved in publicising and helping arrange the event. HW to contact Janet Deacon once confirmed by DR that this is the person to contact. HW & DR to action

NOTES FROM MEETING ON 5 DECEMBER 2023

Present: Margy Longhurst (ML), Shan Oakes (SO), Helen Westmancoat (HW) (Notetaker)

13th August 1770 was the day commissioners and local people met to discuss the implications of the Enclosure Act. We propose to make **13 August 2025 Knaresborough Day** to commemorate but also celebrate how things have moved on. 13th August 2025 will be 'Knaresborough Day' to commemorate the enclosure of the Forest through the Enclosure Act 1770, and to celebrate the people buying back the once common land (Knaresborough Forest Park)

HW will discuss with clerks the list of VIPs and sending them that date. She will also talk to FEVA, Matt Walker and Hannah Gostlow re NYC rep **Action HW**

ML will – talk to Museum, Castle Museum, KJS. Historical society, Charlotte Gale re Cliff lift and feasibility study. **Action: ML**

SO will - talk to Knaresborough Forest Park, Renaissance Knaresborough, Civic Soc, Studio 3, David Rhodes re date for 2030 and leaflet update. **Action: SO**

Also discussed was an outline plan for the day starting at the Castle Top with children performing, moving down to Knaresborough House where lunch could be provided for dignitaries and/or family picnics in the grounds. There would be opportunity for speeches, talks, and the significance of the event, with David Rhodes speaking and possibly the Chair of the Northern Forest. The Mayor could lead the walk through the town which would then go on to Conyngham Hall and the Knaresborough Forest Park.

Next planning meeting – Mon 29 January 2024 with wider invited group at Knaresborough House. HW to chair, SO to take notes. Emails will be sent out to interested parties. **Action: All**

KNARESBOROUGH TOWN COUNCIL TASK AND FINISH GROUP FOR THE 2025 ENCLOSURE ACT COMMEMORATION

Notes of a meeting at Knaresborough House on 29 January 2024

Attendees: Helen Westmancoat (KTC, Chair), Margy Longhurst (KTC), George Eglese (Civic Soc,KFP), Hilary Gardner, David Rhodes, Sue Almond (Historical Soc), Kathy Allday (Museum Assoc), Ruth Bulmer (Museum Assoc), Hannah Gostlow (NYC, KTC), Matt Walker (NYC, Castle WG), Mark Flood (Lions KFP KTC), Chris Kitson (LLC), Rick Brewis (KFP), Trisha Sanders (KFP), Rowena Lloyd (FEVA), Shan Oakes (KTC/RK, minutes), Bill Rigby (Civic soc/RK),

Apologies: Charlotte Gale, Peter Lacey, Sue Vasey, Elsa Wiehe

The meeting was called to consider ideas for framing events around the 255th anniversary of the Enclosure of the former Royal Forest of Knaresborough.

The date of the signing of the Enclosure Act was 13th August 1770 (at the Borough Bailiff, now the Commercial Hotel), so that date in 2025 (Wednesday) is the 255th anniversary. That will be during FEVA. (NB August 12th is the town's Charter Day).

The idea so far is to plan a small-scale event for this August (2024) as part of FEVA and maybe call it Knaresborough Forest Day as we can make it a celebration of the new Knaresborough Forest Park coming back into the ownership of the people.

The suggested plan for the day on **13 August 2025** would be to start at the Castle with various activities, looking across at the new Knaresborough Forest Park, then walk down Kirkgate to Knaresborough House grounds for a picnic lunch and talks etc, then continue down to Conyngham Hall kiosk and grounds. Those wishing to could then continue up to Knaresborough Forest Park.

For August 2025 Rowena is planning an outdoor semi-immersive production inspired by the Castle Yard Riot (NB new book available from Museum Association or Castlegate Bookshop). The theme of the Riot is the importance of the people using their power to retain their rights of access to the land. The Enclosures took away the people's right of access to the Forest – a massive blow – to be commemorated rather than celebrated.

There was discussion covering the value of the community coming together, protecting green spaces, and looking at how best to celebrate people and place and including practical activities like tree planting. It's the UNenclosure of the forest (the

land going back to the common people) we will celebrate, whilst remembering our history and what happens if we relax too much and allow the 'authorities' to get the bit between their teeth.

Discussion about the former Royal Forest of Knaresborough reminded the meeting of its full extent (over 90 miles of boundary), lack of informed interpretation of its heritage value, and unexploited potential for recreation. The development of the 100 acres of Longlands Common, incorporating Knaresborough Forest Park, was a powerful gesture towards the restoration of citizens' free access to the land, and enjoyment of the benefits of the 'commons'.

In support of this, the meeting heard of emerging discoveries by the Knaresborough Museum Association of ancient settlements, and the potential for more insights to be made available through access to previously unexplored areas within LLC/KFP. We need to learn from the past and from nature. Also shared were ideas for the creative opportunities in drama, music and other artistic initiatives prompted by the idea of a regular date in the calendar. KFP outlined the current thinking on a calendar of events throughout the year aimed at generating interest and cultivating an audience of people committed to supporting the Project, together with a network of agencies with similar aims. We hope for a ballad of Knaresborough Forest and lots of inclusive intergenerational activity.

The chair asked everyone to go away and think about what their respective organisation's contributions to the day, and leading up to it, might be. **Action: ALL**

We originally thought of re-establishing a Knaresborough Day on 13th August as an annual event beginning in 2025; however, an opinion was voiced that this needed further deliberation. We can rethink this idea at our next meeting.

Suggested dates are: March 2024 – follow up to this meeting; May 2024 – KFP Beltane walk the land; Aug '24 – FEVA Forest celebration; Aug 2025 August 13th Enclosure/ Castle Yard Riot event
