KTC Latest Comments: KTC objects to this application as the size of the development is out of keeping with the location and will have an adverse impact on the street scene. Removal of the ancient hedgerow will have an adverse impact on biodiversity. The lack of design and landscaping at this point clearly does not offer sufficient protection both in terms of noise nuisance and light pollution to the surrounding area. The increased number of cars on the site will lead to increased transporters, leading to a negative impact in terms of use of the highway on a dangerous bend. However, if HBC is minded to grant approval to this application KTC asks that a condition is imposed in regard to the lighting to ensure that the lights are facing downward and that they are turned out between 12.00 midnight and 5.00 a.m. in consideration of the amenity of the local area and its wildlife. A further condition is requested to ensure the retained access point to the new area is for emergency use only.

- ➤ The Clerk thanked Councillor A Willoughby for all the hard work he had done in checking the Christmas lights on a daily basis. Members echoed this thanks.
- ➤ The Clerk mentioned that she is dealing with three FOI requests, all relating to the Christmas lights.
- ➤ The Clerk mentioned that a date needs to be set when the Christmas lights in the market place, Frazer Theatre tunnel, and Kirkgate should be turned off but members indicated they would like to see costings of extending the lighting period. Clerk to investigate. It was also suggested a meeting with the contractor would be beneficial to discuss several issues.
- ➤ The Clerk mentioned that it is apparently a requirement of the council's auditors to carry out an audit when the Clerk is leaving office.
- ➤ The Clerk showed members photographs of the damage at the King George V field which had been caused by cars on the grass. The football pitch is currently not fit for use and Members agreed that fees should not be charged whilst it is out of action. The Clerk to report the damage to the police. Commuted sums were mentioned, and Councillor C Willoughby will check exactly what they can be used for in regard to King George V field repairing damage, erecting fencing etc.

- Councillor Clemmitt mentioned that next year will celebrate 50 years of Town Twinning with Bebra. Funding will be needed. She informed members that Councillor Rigby and Shan Oakes are organising a quiz which is being held on Friday 2nd February with a German themed supper, bar, music etc. Tickets will be priced at £8 and are available from the Tourist Information Centre, the Olde Chemist Shop, Knaresborough House and Councillor Bill Rigby. Councillor Rigby suggested that may be the town council could put together a team!
- Councillor Aspin thanked all those involved with the Christmas Nativity this year's performance will be on 20th such event to be held on Christmas Eve.
- Councillor C Willoughby informed members that there will be a Castle Working Group meeting on Wednesday 10th January at 10.00 am, and the Knaresborough in Bloom AGM will be on 16th January.
- ➤ The Deputy Clerk mentioned that only one councillor had responded to the invitation to attend the Charity and Community Seminar being held at Knaresborough House on Saturday 20th January. The Mayor then spoke about the rationale behind this event and the aim to improve co-operation between voluntary sector members within Knaresborough. He mentioned that HRCVS and Two Counties would be presenting during the morning, outlining new funding initiatives which are being developed for the voluntary sector.
- ➤ The Mayor went on to update members regarding NDP. He explained that working group members were continuing to work through the analysis of the responses received on line, and the paper responses. The group is currently working on the responses from HBC, NYCC etc. He confirmed that within the next couple of weeks there will be a report with a recommendation in terms of how the NDP document needs to be further developed/modified.
